Whilst all transactions occur on-chain – Mr.Tipbot operates as a custodial wallet, which means that it stores your cryptocurrency funds in a wallet that it manages on your behalf. Whilst we take reasonable measures to ensure the security of your funds, the Service still presents inherent custodial risks. By using the Service, you agree to store the amount of funds necessary for tipping and when in excess will withdraw to your self-custody wallet.
